Children's law is a public-private legal discipline, but with a strong propensity for multidisciplinarity. Traditionally linked to family law, children's rights in Portugal have been given the autonomy and importance they deserve, both because Portugal is a European country and a party to several international and European conventions on the subject, as well as being the recipient of several Council of Europe Recommendations; or the fact that there are countless legal institutes that are interrelated, in a true interdisciplinary dialogue that goes beyond family law to include criminal law, human and fundamental rights, and also has a strong substrate in the areas of psychology, neuropsychology, medicine and other forensic sciences. In view of the socio-legal importance of children's law, it calls for a re-personalisation of the subjects who deserve legal protection, especially in the face of sensitive and complex issues. Faced with the need to look at children with the dignity they deserve, but in a systematic way to deal with the issues involved, this course addresses various themes across the board, including, alongside the analysis of legislation, the contribution of different areas of knowledge, in an unequivocal and necessary multidisciplinary and
